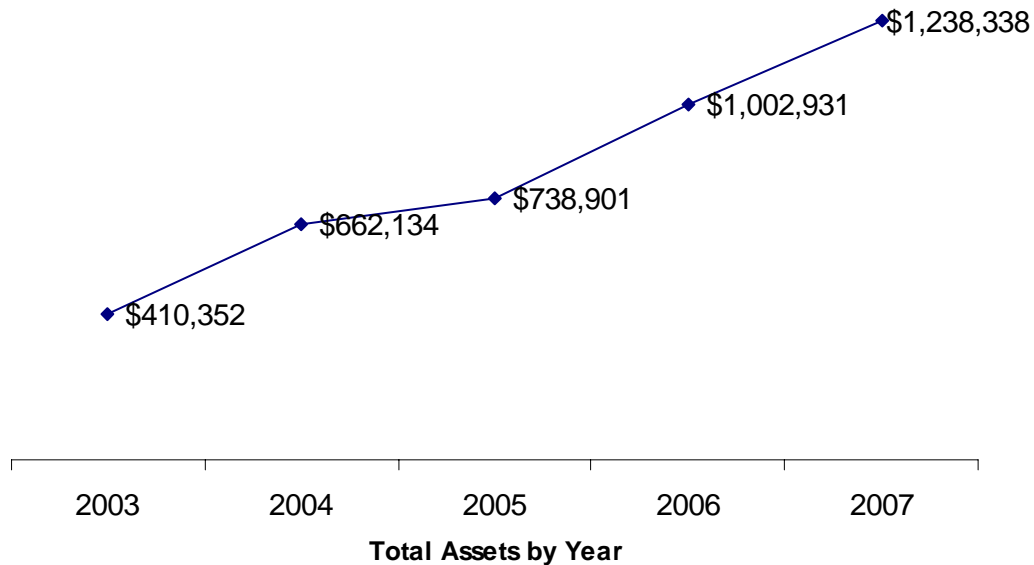

Impact Fund for Cloud County Grants—\$30,720.00

Impact Fund for Cloud County grants come from the generosity of donors who contribute to the Foundation's unrestricted grant fund.
